**Summary Annual Report for**  
**TEAMSTER LOCAL 282 ANNUITY TRUST FUND**

This is a summary of the annual report for TEAMSTER LOCAL 282 ANNUITY TRUST FUND, EIN 11-6276104, Plan Number 002, for the period March 1, 2019 to February 29, 2020. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the plan are provided by a trust and insurance and/or annuity contracts. Total plan expenses were \$40,733,543. These expenses included \$3,312,001 in administrative expenses and \$36,273,155 in benefits paid to participants and beneficiaries, and \$1,148,387 in other expenses. A total of 5,531 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$714,062,979 as of February 29, 2020, compared to \$656,806,484 as of March 1, 2019. During the plan year the plan experienced a change in its net assets of \$57,256,495. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$97,990,038 which included employer contributions of \$59,096,007, employee contributions of \$0, gain/loss of \$2,923,680 from the sale of assets, and earnings from investments of \$35,970,351.

The plan has (a) contract(s) with THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, THE UNION LABOR LIFE INSURANCE COMPANY, and PRUDENTIAL RETIREMENT INSURANCE AND ANNUITY COMPANY, which allocates funds toward unallocated investment contracts with insurance companies. The total premiums paid for the plan year ending February 29, 2020 were \$0.
