## TEAMSTER LOCAL 282 ANNUITY TRUST FUND

This is a summary of the annual report for TEAMSTER LOCAL 282 ANNUITY TRUST FUND, EIN 11-6276104, Plan Number 002, for the period March 1, 2017 to February 28, 2018. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Basic Financial Statement

Benefits under the plan are provided by a trust and insurance and/or annuity contracts. Total plan expenses were \$32,748,484. These expenses included \$3,658,758 in administrative expenses and \$28,371,598 in benefits paid to participants and beneficiaries, and \$718,128 in deemed distributions. A total of 5,125 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$605,783,658 as of February 28, 2018, compared to \$556,548,365 as of March 1, 2017. During the plan year the plan experienced a change in its net assets of \$49,235,293. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$81,983,777 which included employer contributions of \$52,849,751, gain/loss of \$-266,157 from the sale of assets, earnings from investments of \$29,183,258 and other income of \$216,925.

The plan has (a) contract(s) with THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, THE UNION LABOR LIFE INSURANCE COMPANY, and PRUDENTIAL RETIREMENT INSURANCE AND ANNUITY COMPANY. The total premiums paid for the plan year ending February 28, 2018 were \$0.
