This is a summary of the annual report for LOCAL 282 JOB TRAINING TRUST FUND, EIN 11-6399999, Plan Number 503, for the period March 1, 2022 to December 31, 2022. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BOARD OF TRUSTEES LOCAL 282 has committed itself to pay the following types of claims incurred under the terms of the plan:

- Certain job training and apprenticeship claims

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,868,896 as of December 31, 2022, compared to \$1,828,435 as of March 1, 2022. During the plan year the plan experienced a change in its net assets of \$40,461. The plan had total income of \$478,006 which included employer contributions of \$454,870, employee contributions of \$0, gain/loss of \$0 from the sale of assets, earnings from investments of \$525, and other income of \$22,611

Total plan expenses were \$437,545. These expenses included \$173,389 in administrative expenses and \$264,156 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
