**Summary Annual Report for  
LOCAL 282 VACATION & SICK LEAVE TRUST FUND**

This is a summary of the annual report for LOCAL 282 VACATION & SICK LEAVE TRUST FUND, EIN 11-6438921, Plan Number 505, for the period March 1, 2012 to February 28, 2013. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$6,979,182 as of February 28, 2013, compared to \$6,806,362 as of March 1, 2012. During the plan year the plan experienced a change in its net assets of \$172,820. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$10,376,923 which included employer contributions of \$10,313,803, employee contributions of \$0, gain/loss of \$1,576 from the sale of assets, and earnings from investments of \$21,627

Total plan expenses were \$10,204,103. These expenses included \$375,448 in administrative expenses and \$9,828,655 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
