**Summary Annual Report for

This is a summary of the annual report for LOCAL 282 WELFARE TRUST FUND, EIN 11-6244552, Plan Number 501, for the period March 1, 2014 to February 28, 2015. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has (a) contract(s) with Emblem Health, UNICARE LIFE & HEALTH INSURANCE COMPANY, Metropolitan Life Insurance Company, United Healthcare Insurance Company, and United American Insurance Company to pay the following types of claims incurred under the terms of the plan:

The total premiums paid for the plan year ending February 28, 2015 were \$5,125,587.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$126,782,066 as of February 28, 2015, compared to \$119,834,764 as of March 1, 2014. During the plan year the plan experienced a change in its net assets of \$6,947,302. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$69,350,450 which included employer contributions of \$52,890,132, employee contributions of \$182,671, gain/loss of \$277,679 from the sale of assets, and earnings from investments of \$10,610,566

Total plan expenses were \$62,403,148. These expenses included \$10,018,281 in administrative expenses and \$52,384,867 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
