**Summary Annual Report for**  
**LOCAL 282 WELFARE TRUST FUND**

This is a summary of the annual report for LOCAL 282 WELFARE TRUST FUND, EIN 11-6244552, Plan Number 501, for the period March 1, 2019 to February 29, 2020. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BOARD OF TRUSTEES LOCAL 282 has committed itself to pay the following types of claims incurred under the terms of the plan:

- Certain medical, hospital, prescription drugs, dental, and other claims

**Insurance Information**

The plan has (a) contract(s) with Humana Ins. Co. of New York, Humana Insurance Company, GARDEN STATE LIFE INSURANCE COMPANY, Emblem Health, Transamerica Premier Life Insurance Company, The Standard Life Insurance Company of New York, SIERRA HEALTH AND LIFE INSURANCE COMPANY, and Prudential Retirement Insurance and Annuity Company to pay the following types of claims incurred under the terms of the plan:

- Certain hospital, surgical, medical, medicare Parts A,B,&D, & other claims

The total premiums paid for the plan year ending February 29, 2020 were \$4,681,472.

Because (it is a) (they are) so called "experience-rated" contract(s), the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending February 29, 2020, the premiums paid under such experience-rated contract(s) were \$265,273 and the total of all benefit claims paid under the(se) experiences-rated contract(s) during the plan year was \$190,000.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$146,875,453 as of February 29, 2020, compared to \$140,484,253 as of March 1, 2019. During the plan year the plan experienced a change in its net assets of \$6,391,200. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$108,327,709 which included employer contributions of \$91,065,253, employee contributions of \$231,058, gain/loss of \$372,536 from the sale of assets, and earnings from investments of \$16,658,862

Total plan expenses were \$114,091,318. These expenses included \$10,807,157 in administrative expenses and \$103,284,161 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
